**NGEN Annual Meeting 1-30-25 – CANCELED:**

The in-person Annual Meeting scheduled for Crystal City Va on 1-30-25 has been canceled due to the lack of funding. If/when some of the questions around the NGEN's future have been resolved, a virtual Annual Meeting will be scheduled at a later date.

**Multi-State Venture Car procurement as of 10-10-24:**

*All coach type FDR and FAI stages are complete, including Cab Car and Café Car.*

*The Cab Car FAI and FRA sample car inspections are complete, and the first cars have been conditionally accepted. The Cab Car 238.111(b) testing is complete, and the test report is nearly complete. The IDOT café cars are being shipped to Chicago and placed into revenue service as available.*

*All 137 cars are in production or have been produced at Siemens Sacramento Facility. IDOT coaches and Caltrans trainsets are being added to revenue service as they are commissioned and accepted.*

**Next Update: 12-5-24**

**Document Control Activities as of 11-21-24:**

*Due to the current unknown future of PRIIA, I am working on determining what can be completed in the TSC and approved by the EB by the end of March.*

*The Technical Writer and I are working on finalizing a list of the PRIIA specs that we can finish de-Amtrak before March.*

*The Single-Level specification will be completed as soon as the Mechanical WG can finish their last DCR. They are waiting on some information from AAR. This should be completed by March.*

*The Vehicle Weight WG is working to expedite their recommendations before March.*

*I still need to determine the timelines for the Communications and Materials WGs.*

**Metro-North Dual Mode Locomotive Procurement:**

Ray Hessinger reported that the first two Locomotives had been delivered to Metro-North at Croton Harmon, NY in late October 2024 and were starting the process of inspection for acceptance.

**Connecticut DOT Rail Car Procurement:**

**CtDOT Rail car Procurement as of 11-7-24 – provided by CtDOT:**

*We're working on reviewing and approving the last of the PDR documents. Planning for in person IDR meetings with the design team in December 2024 and January 2025.*

**Next Update: 12-5-24**

**Update: Amtrak Vehicle Procurements as of 11-7-24:**

On the new Acela:

All is moving along at a steady rate – they are working on final qualification testing and going forward with training.

On Airo:

This procurement is progressing well and is on schedule for spring 2025 for testing the first trainset on the corridor. There are 72 coach cars and 7 locomotives in production.

On the ALC 42:

Dan reported that this procurement continues at a steady state – averaging one or two a month. There are 64 in service out of a base order of 75. There will be a little slower rate going forward as they turn to the option order of 50.

On the Long-Distance Trainsets:

Continues as an active RFP. Amtrak is continuing to work with carbuilders with a goal of an award next year.

On the GP38 – 10 are in production, 5 are on site and 21 of 36 have been conditionally accepted. (Nothing new reported on this procurement on 11-7-24.)

Melissa Shurland, FRA, provided an overview on FRA Rolling Stock Research potential topics for discussion on future NGENC Technical subcommittee calls. This list followed a discussion that Melissa Shurland and others from FRA R&D had with Steve Hewitt and Dan Ruppert.

5. *US-ISO Standards Group*
6. *WhMD (wheeled mobility device) Sled Test*

**Next presentation – second meeting in January 2025**

**NGEC Future Funding Status 11-21-24:**

Steve Hewitt reported that NGENC long-term funding has not yet been resolved. The Committee is currently being provided gap funding from Amtrak. Initially the funding was to go through 12-31-24 while more long-term options are being explored. As of 10-29-24, Amtrak had approved a total of \$100,000 for the NGENC beginning on 10-1-24 and running through 3-31-24. Amtrak will provide AASHTO with a note extending the Amtrak/AASHTO agreement through 3-31-24 and AASHTO will do the same with the sub-contractors. This provides the NGENC with additional time to explore potential long-term and short-term funding.

The FASC met on 11-20-24 and discussed some next steps – first step will be to continue to follow-up with Amtrak Government Affairs to determine if there is an internal solution outside of Amtrak Mechanical which has expended all that it can.

The second step, if internal Amtrak solution cannot be found is to go back to FRA to discuss if there are any additional short-term and/or long-term solutions.

While funding the NGENC and its future, overall, is being determined, the NGENC continues to conduct business as usual.

Dan Ruppert said that Steve's update was in "perfect alignment" with conversations he, Tim Ziethen and George Hull have had this week. As it stands now, the NGEC does not have funding beyond March 31, 2025.
